


This matter has been discussed at Board level, wherein it was requested that a copy of this letter be sent to you so that you are aware of this issue.

Dear Paul

Anglican Care is a significant provider of aged care services in both the Hunter and Central Coast areas. We are experiencing continuing and increasing pressure to accept "younger people" into our residential care services.

Anglican Care does have a policy not to accept people aged under 55 unless exceptional circumstances exist. I am conscious of the funding restraints of the system, and our mission at Anglican Care is to the aged. We have, in recent months, had to reject the applications of two people aged in their forties. We are very aware of our role in the community and our commitment to the financially and socially disadvantaged. These decisions were the correct ones on a contractual and legal ground, however, the contingent damage to our reputation is causing great angst to the Board, Executive and Staff of Anglican Care. These circumstances, in all probability, will continue to increase and Anglican Care seeks direction and advice on these challenges.

The two applications we rejected were one person with a diagnosis of Huntingtons Chorea and the other was a person suffering end stage renal failure, coupled with severe dementia.

There is no doubt we are all compassionate people but the decisions to reject these people have been made against some of our values. The decision to admit would have put Anglican Care in conflict with the Department's stated position on these sufferers.

I am bringing these matters to your attention in an attempt to raise the profile of these needy people, who have clear and real health needs that are unable to be met in the community.

We hope this letter will stimulate a positive response from the Department to develop, with others, strategies to deal with these people.
