## Inquiry into Temporary Residents' Superannuation Legislation Amendment Bill 2008 and the Superannuation (Departing Australia Superannuation Payments Tax) Amendment Bill 2008

On 25 September 2008, the Senate referred the Temporary Residents' Superannuation Legislation Amendment Bill 2008 and the Superannuation (Departing Australia Superannuation Payments Tax) Amendment Bill 2008 to the Senate Standing Committee on Economics for report by 20 November 2008.

These bills seek to reduce the number of lost accounts and unclaimed money in the superannuation system which can arise when temporary residents depart Australia without taking their superannuation with them. The Temporary Residents' Superannuation Legislation Amendment Bill requires superannuation funds to pay the unclaimed superannuation of departed temporary residents to the Tax Office. The Superannuation (Departing Australia Superannuation Payments Tax) Amendment Bill enables departed temporary residents to claim their superannuation benefits through the existing departing Australia superannuation payment process, before it becomes unclaimed.
