## Inquiry into funding matter under the Dairy Regional Assistance Programme.

During the inquiry on 8 May 2003 the Department took several questions of the Committee on notice, as the detail of information sought from these questions was not at hand at the time. The answers to these questions have now been prepared and can be found at Attachment A.

On 28 May 2003 the Committee Secretariat also requested that several additional documents relating to the Moruya Steel Profiling Plant Dairy Regional Assistance Programme project be provided. Included at Attachment B is a response and copies where appropriate.

Reference: Inquiry into a funding matter under the Dairy Regional Assistance Programme

- Q. (1) The number and total value of the Dairy RAP grants made to the Eurobodalla region.
- A. From rounds one to nine, the final Dairy RAP round, \$ 638,406 in funds were approved for 7 projects in the Eurobodalla region.
- Q. (2)
  - i) When did applications for round 6 open, and
  - ii) close
- A. i) Applications could be received post ACC endorsement at any time. Applications were then considered for a following round.

- A. The proponent's. It was common practice, when assisting an applicant to develop their proposal, to discuss the issue with the applicant, then, as a matter of convenience, to amend the application with the applicant's permission.

- Q. (7) Was an application made by the Eurobodalla Shire Council to Regional Solutions to sewer the North Moruya Industrial Estate (lodged in November 2000 seeking \$302,220).
- A. Yes. An application was received by DOTARS from the Eurobodalla Shire Council on 20 November 2000 seeking \$302,200 to assist the extension of the existing sewerage system to the North Moruya Industrial Estate.

- A. Yes. The application was received electronically. The department has signed copies of the document submitted on 3 December and the document submitted on 12 December.

**Project Description** 

This DRAP project will allow the expansion of Moruya Decking & Cladding Pty Ltd's (Mordek's) operations. The project involves the construction a new building, and installation of additional machinery including machinery of a type not yet used at the existing Moruya plant which will allow for an increase in both the quantity and variety of products provided by the company.

The planned site of the expansion, at North Moruya, is not yet sewered. Eurobodalla Shire Council have undertaken to install the sewer as soon as possible, with headworks partially paid for by the proponent organisation. DRAP funds applied for will not be used to purchase goods or services relating to the provision of sewerage headworks. DRAP funds will be used to pay costs associated with the construction and fit out of the new factory premises.

What will DOTARS funds To pay for the building and fit out costs associated with the expansion of

Mordek's operations in Moruya.

**Expected Outcomes** 

The project will increase by 8-10 the number of full time persons directly employed by Mordek within the plant.

Additionally within 3-6 months of commencement of operations a further 6 full time jobs will be created in shed erection division (2 teams of 3 employed by Mordek or an associated company). It is possible that some of these people may also be employed to assist in the construction of the facility.

In total the project will directly lead to the creation of an additional 14-16 full time jobs within the Eurobodalla.

The ongoing regional benefit will be considerable. The industrial estate where this project is to take place has the potential, when fully utilised, to be the place of employment for several hundred persons. It should be noted that Batemans Bay, a much larger nearby centre, has effectively run out of industrial land.

#### Qualitative information

#### BACKGROUND

Mordek has operated in the steel products market since 1979. The company now operates plants in Moruya, Nowra and Canberra.

The company has identified opportunities in shed manufacturing, metal brick clad products, and ceiling battens. Although the region has retail and trade outlets dealing in these products, there is no comparable manufacturer.

As well as reaching domestic markets, there is significant international demand for the items which can be produced by the new equipment.

According to Eurobodalla Shire Council (ESC), the estate at North Moruya on which the new facility is to be constructed is the only significant parcel of industrial land remaining in its shire area. ESC is of the view that once the industrial estate has sewerage available, a number of projects which have been delayed by the shortage will commence.

In addition to this project (as described in the DRAP application) the proponent will be paying for the local council to provide sewerage headworks to the estate. This will have an added benefit of providing the necessary infrastructure to allow for for economic development within the Eurobodalla. DRAP funds will not be contributing directly toward the provision of sewerage headworks, as this was deemed to be providing a competitive advantage to the property owner/developer. The project as described in the application does not include the provision of sewerage headworks which is viewed as being separate from the activities which are the subject of the DRAP funding submission. No spending by the proponent on the sewerage headworks has been counted toward their contribution for this project.

#### **DEWR ASSESSMENT**

## 1) Strong Linkage to a Dairy Dependent Community

The project is based in the dairy dependent region of Eurobodalla.

The Eurobodalla region has been assessed by ABARE as HIGH in terms of average on farm impact resultant from deregulation and LOW in terms of regional dependence upon the dairy sector.

The Eurobodalla SLA contains 29 dairy farms.

#### 2) Significant and Sustainable Benefits

The project will generate 16-18 direct jobs once the new plant is operating.

The number of indirect jobs has not been calculated. The likely impact is considerable.

In terms of jobs provision it is important to note that the Eurobodalla has an unemployment rate significantly higher than the state average. In the March quarter Small Labour Markets Report it was found that Eurobodalla unemployment rate (4qtr average) was 13.5% whilst the state average was 6.2%. The provision via this project of an additional 16-18 jobs plus the infrastructure development that would allow for further jobs growth is of enourmous benefit to this depressed labour market.

#### 3) Co Funding

The proponent is a commercial entity with co-funding of \$310,000 in cash and \$10,000 in kind. The proponents cash contribution represents more than 50% of the new investment (GST exclusive) to be established through the DRAP funded project.

#### 4) Financial Viability

The proponent has provided detailed financials and business plans. The proponent was determind to be finacially viable by the DEWRSB Financial Analyses Team.

In terms of the amount requested and given the nature of the project and the information provided by the proponent an external assessment of this project was requested.

The external report found that while Mordek's operating profit was low, they had over the past three years engaged in significant capital expansion. The report found the proponents project financials and projects to be reasonable and determined that in terms of the DRAP guidelines the proponent had

provided evidence that supported the viability of their project and their ongoing operations.

The report noted that the proponent did not have the resources to undertake the project without DRAP assistance.

#### 5) Management Capacity

Mordek has operated successfully in Moruya for over twenty years. The company currently employs over 25 staff through its Moruya operation. Given the company history, the high quality of the additional information provided and the response to information requests to date the proponent is assessed as having the management capacity to undertake the project.

#### 6) Budget Analysis

The budget for the project is valid. The costs associated with the construction work have been backed up by the provision of a written quote for the work.

The external report made comment that some items included in the original project budget to be funded, or subsidised, by DRAP support may construe a competitive advantage to the proponent organisation thereby breaching the Commonwealths policy of competitive neutrality.

The Department has taken this finding back to the proponent whereby the project was altered through negotiation and those aspects that may have caused a compeitive advantage have been removed from the DRAP project.

This negotiation also resulted in the amount of funding requested being reduced by around \$100,000.

#### 7) Value for Money

In terms of direct job outcomes (14-16) and sustainable regional benefit this project offers good value for money. The successful negotiation of the funding amount requested has further improved this projects claims with respect to value for money.

#### 8) Project Plan and Evaluation Process

The project application contains a detailed project plan with measurable performance indictors.

The project will be independently evaluated at completion against the project plan and the objectives and performance indicators contained within.

#### 9) Market Research

The company has identified opportunities in shed manufacturing, metal brick clad products, and ceiling battens. The company business plan contains detailed market research.

The external consultant's report also investigated the market into which the new plant will operate. The report found that Mordek was strongly placed to use the increased production to enter the lucrative export market.

The external report did note that any downturn in the domestic building industry would significantly impact Mordek.

#### 10) Competitive Neutrality

The business plan provided with the application notes Mordek's main competitors. None of these competitors operate out of Moruya, or the Moruya area. As this region has a rapidly expanding housing sector, sales of building products are also on the rise. Given these factors, it is unlikely that Commonwealth assistance to this project will adversely impact Mordek's competitors.

As noted at 6) negotiation with the proponent has moved the project away from activities that may have construed a competitive advantage. As the revised application has addressed the competitive advantage issues raised by the external consultant, the project, if funded is not now anticipated to impact upon the Commonwealths policy of competitive neutrality.

#### Recommendation

This project is recommended for funding. The external report on the project found that the project is eligable for DRAP funding given that certain changes were made to the project. Negotiation between the Department and the proponent have seen these changes adopted in a revised application.

- 1. The project is to operate within the Eurobodalla, a region identified as a Dairy RAP Target Region
- 2. The 14-16 fulltime jobs which will stem from the project will be of significance and benefit to the local community.
- 3. The application has demonstrated that the project will result in sustainable job outcomes.
- 4. The application and in all dealings, the proponent has demonstrated good management. The proponent was found to have the organisational capacity and the financial status to undertake and successfully implement the project. The project application contains realistic budgeting and achievable outcomes. The project will be completed prior to the end of DRAP funding.
- 5. The proposal has been found to be viable, and6. The project exhibits partnership funding from the proponent that represents more than 50% of new investment expenses.

"The ACC is well aware of the need for industrial land in the Eurobodalla. Additionally, although dairying in Moruya is overshadowed by the size of the industry in Bega, it is nonetheless a significant part of the local economy which was in decline even before the current deregulation commenced. As a consequence, Moruya desperately needs employment in new, clean industries such as Mordek's proposal. Demographic studies suggest that there will be significant regional building activities over the next few years. If this project does not go ahead, most of the building supplies used will be produced elsewhere.

Mordek has a good track record and is capable of fulfilling these goals. The ongoing regional benefits will be enormous."
