Background

The Grace Munro Centre at Bundarra is an aged care facility which has been funded through a number of sources but strongly led by the Uralla Shire Council and local community leaders.

I believe that the series of events leading to and following the Opening of the Grace Munro Aged Care Centre at Bundarra concur with the Senate Committee's Terms of Reference 1(L) and gets to the heart of our representational process and privileges of the Member.

- The documents enclosed particularly those presented in the form of a Statutory Declaration by the General Manager of Uralla Shire Council, Robert Fulcher, demonstrate the political pressure and bullying by Senator Sandy Macdonald to obtain political advantage.
- The press clippings surrounding the opening and subsequent events clearly shows the deliberate attempt by Senator Macdonald to coerce and threaten a Council into removing the right of the duly elected Member for communicate with his constituents.
- Senator Sandy Macdonald also misled the public and the press on a number of occasions.
- 1. 10 November 2005 Senator Macdonald's email asking that Mr Windsor's name be deleted from the plaque stating as a reason to the Inverell Times (December 17 2005) that he was under a lot of pressure at the time as Mr Windsor had named him in Parliament as part of an inducement offer not to stand at the next election.

Senator Macdonald also cited the same reason in The Australian (December 16 2005).

The question that needs to be asked is what was Senator Macdonald annoyed about on November 10 if he wasn't named until November 17?

If he had no knowledge of the "inducement issue" prior to his name being raised in Parliament on November 17, why was he so "upset" on November 10?

2. Senator Macdonald's misrepresentation of the Government's position by stating that it was the Government's position that the Local Member should not be part of an official function within his own Electorate. This is another example of a political condition being placed on a public body for political advantage.

I believe the behaviour of Senator Macdonald deserves closer scrutiny. His conduct is in stark contrast to the professional courtesies and advice extended to myself as the local member and Uralla Shire Council by the current Minister for Ageing, The Hon Julie Bishop, the former Minister the Hon Kevin Andrews, the former Minister for Regional Services, The Hon Wilson Tuckey and their Departmental staff who had carriage of funding arrangements. To them I extend a thank you on behalf of the people of Bundarra and Uralla Shire Council.

Council emails reveal litical interference

THE Nationals' NSW Senator Sandy Macdonald ordered the Uralla Shire Coun-cil to delete Independent Member for New England Tony Windsor's name from the plaque on the Grace Munro Centre at Bun-

Documents obtained by The Inverell Times under Freedom of Information laws reveal that the Uralla Shire Council had submitted the suggested wording for the plaque - which included Mr Windsor's name - to Senator Macdonald's office for approval on November 10.

But an email from Senator Macdonald's Tamworth office to the council one hour later stated: "The Senator has asked if these changes would be made."

Tensions between the two politicians had been simmering after Mr Windsor named Senator Macdonald and the Leader of The Nationals, John Anderson, as being behind an offer of a diplomatic posting in

Federal election.

They were subsequently cleared by an Australian Federal Police investigation.

Political funding under the Regional Partnerships and Sustainable Regions programs is, however, now the subject of a



said that aithough they were touched by the Shire Council's gesture, they did not expect another plaque to be erected on their behalf.

They said they appreciate Ural-la's attempt to avoid any further political embarrassment over the opening of the Grace Munro Centre, but a fourth plaque was not necessary

"I greatly appreciated the ges-ture, but at the end of the day plaques don't mean a lot to me,"

Mr Windsor said

"I'd prefer they spent the money on buying another piece of furniture, a bed or a chair, than another piece of metal out the front," he said. Mr Torbay said he would be

happy to forfeit having his name on the fourth plaque, in lieu of recognition for the people of Bundarra who never gave up hope in seeing their dream of an aged care facility come to fruition.

"The people of Bundarra are the real champions," Mr Torbay

"They drove this project long before the politicians, any of us, got involved," he said.

"Senator Macdonald has said he regrets the incident but the only thing he is sorry about is getting caught out," he said.

Mr WINDSOR (2.32 p.m.) —My question is to the Acting Prime Minister. Is the Acting Prime Minister aware that Senator Sandy Macdonald advised Uralla council that he did not want me to be part of the official opening of the Grace Munro Centre in my electorate? Is the Acting Prime Minister also aware that the Mayor of Uralla has issued a press release today saying that the council never had a problem including me in the official party and that the decision not to do so was made in light of demands made on behalf of the government by Senator Sandy Macdonald? Has Senator Macdonald misled the public? Do you agree with Senator Macdonald's representation of the government?

Mr ANDERSON —I have not spoken to Senator Macdonald about the function at Uralla. I was advised by my office that the member for New England had been invited to it. I just make this point: I do feel that the member for New England has some right to be aggrieved when it comes to statements put before parliament. I have to say that. We are in a situation, I say to the member for New England, where he has made outrageous allegations based on hearsay which he has not been able to substantiate anywhere else, which he will not repeat anywhere else and which, I note, nobody is prepared to back or take up, not even those opposite. I presume that the normal courtesies will be extended to the member for New England—no more, no less.

- That if Council wished Ministers of the government to attend the official opening of the Centre, it will be necessary for Council to ask Senator Macdonald directly.
- In response to my comments that Mr Windsor had been democratically elected as our local member and the correct protocol was to approach the government through the local member, Senator Macdonald said that that may be correct but what we were dealing with here was hard ball politics and political reality.
- 5. Having discussed this matter with the Mayor, who had also spoken to Senator Macdonald, it was agreed that I should write directly to Senator Macdonald asking him to invite the Ministers to attend the official opening. I did so by letter which was faxed on 29 October 2004 (copy attached).
- 6. By letter dated 28 October 2004 (attached), Mr Windsor advised that he had written to the Minister for Ageing, the Minister for Transport and Regional Services and the Minister for Veteran Affairs inviting them to attend the official opening.
- 7. By letter dated 4 November 2004 (attached), the Executive Assistant to the Deputy Prime Minister wrote to Tony Windsor advising that the Deputy Prime Minister would not be available to take part in the opening due to another commitment and that it would be appropriate for Senator Sandy Macdonald to participate on Mr Anderson's behalf.
- 8. By email, sent on 9 November 2004 (attached), the office of the Hon. Julie Bishop, MP, Minister for Ageing, wrote to me advising her inability to attend and that she would like to invite Senator Sandy Macdonald to represent her at the opening of the facility.
- 9. As a result, Council then dealt directly with Senator Macdonald and his office.
- 10. Suggested wording for the official plaque for the opening was forwarded to Senator Macdonald's office on 10 November 2004. The wording suggested by Council included reference to Mr Tony Windsor (copy attached).

- 11. By email, dated 10 November 2004 (copy attached), Senator Sandy Macdonald's office replied requesting changes to the plaque. Those changes specifically involved the deletion of reference to Mr Windsor. The approved wording is attached with that email.
- 12. On 18 November 2004 I drafted a letter to the Prime Minister, for the Mayor to consider sending, seeking the Prime Minister's advice about the correct communication process between Council and the Government (copy attached). Because of the political sensitivity of this issue, the Mayor did not sign the letter.
- 13. By email, dated 23 November 2004 (copy attached), a copy of the draft program for the opening was sent to Senator Macdonald. That draft program, prepared by Council, included Mr Windsor on the official party and a speech by Mr Windsor.
- 14. In response to that program, I had a telephone call from Sandy Macdonald on Thursday, 25 November 2004. He also tried to talk to the Mayor about this matter on the same day. The words he used to me were generally as follows:
 - You have a problem with the official opening.
 - I have looked at the running sheet.
 - The problem is that I won't be on the same podium with Tony Windsor.
 - He has chosen to make allegations concerning me under parliamentary privilege.
 - I am offended by his action.
 - He can be a guest at the function but can't be on the official party and cannot speak.
 - I have no problem with Richard Torbay being involved in the official party he is a very good local member.
 - I am sorry for the problem but it is an issue which Council will need to deal with.
- 15. After I discussed the matter with the Mayor, it was agreed that Council had no option but to remove Mr Windsor from the official party.
- 16. By email dated Friday, 26 November 2004 (copy attached), I advised Mr Windsor that the Mayor had asked me to tell him that he regrets to advise that Council will need to comply with the government's wishes and that he will not be part of the official party.
- 17. A revised running sheet was then sent to Senator Macdonald and to Mr Torbay on 26 November 2004 (copy attached).
- 18. Mr Bruce McLean rang me on Tuesday, 30 November 2004. He said that he had spoken to Mr Jim Booth of Sandy Macdonald's office who had said to Bruce McLean, "If they want to play hard ball, we will too."
- 19. Following discussions with Mr Torbay, Senator Macdonald and Mr Windsor and after review of statements made in parliament and to the media concerning this matter, the Mayor made another decision to include Tony Windsor in the official party and issued a press release on that day to that effect (copy attached).





Communication with the Government

The purpose of this letter is to seek your advice and assistance concerning appropriate protocols and the most effective way for Uralla Shire Council to communicate with the Government and Ministers of the Government.

Uralla Shire council is in the electorate of New England. Its local member is Mr Tony Windsor, MP, who is an independent.

Senator Sandy Macdonald, a Senator for NSW, lives in Tamworth, which is also the location of Mr Windsor's electorate office.

Council recently had occasion to request its local member, Mr Windsor, to invite a Minister of the Government to carry out the official opening of a building in this shire which was partly funded by the Commonwealth Government. In response to that action, both the General Manager and I had separate telephone conversations with Senator Sandy Macdonald. His advice to us was that Council would be more successful in such requests if it made them directly to him and not through Mr Windsor. He also suggested that support for funding applications from Council to the Federal Government should be obtained through him rather than Mr Windsor.

Council's understanding is that the correct protocol is that it should approach the Government and its Ministers through its local member, no matter whether or not that local member is a member of the governing parties. Council has no problem if the Ministers, when approached by the local member, decide to respond to Council through Senator Macdonald, who is a member of the governing parties.

Of prime importance to the Council is that it should not take action which may adversely affect the interests of the residents and ratepayers of this shire in relation to the chances of success of applications and submissions it makes to the Commonwealth Government.

I note that, after the recent election, you stated, in your victory speech, that you govern for all of Australia, whether or not people voted for your party or not. That comment would indicate to Council that it should continue to communicate with the Commonwealth Government through its local member.

Your advice concerning this sensitive issue would be sincerely appreciated.
