SUPPLEMENTARY STATEMENT - COMMITTEE ON REGIONAL AND REMOTE INDIGENOUS COMMUNITIES - 8 OCTOBER 2009 HEARING IN NARROGIN

This is a supplementary statement containing evidence which was omitted by me in the hearing yesterday (8 October 2009).

With respect to my comments relating to primary care services, my reference to Wheatbelt residents being treated as second-class citizens was, without further qualification, factually incorrect. I omitted to state that my comments were limited to the lack of GP services across the Wheatbelt region, during a discussion on primary care services, not a reflection of health care services in general.

I also omitted to state that my comments regarding health funding variations between country and metropolitan communities were in relation to primary care services, in particular General Practitioner (GPs) services across the Wheatbelt. The Wheatbelt has a significant shortage of GPs, with eight vacancies.

I would like to state that the WA Country Health Service – Wheatbelt (WACHS Wheatbelt) does provide a very comprehensive health care service encompassing acute, aged care, mental health and primary health care services.

In order to improve the services that are currently provided, WACHS Wheatbelt in conjunction with the Wheatbelt Development Commission, local government and the GP Network has recently completed an exhaustive community consultation process across the Wheatbelt.

The outcome of this process will inform WACHS Wheatbelt of community views regarding health care services and allow us to formulate a plan that will significantly improve health care across the region.
