Aboriginal and Torres Strait Islander Commission Amendment Bill 2004 Inquiry

Thank you for the opportunity to provide input to the Senate Select Committee on the Administration of Indigenous Affairs Committee on this matter, and the proposed related changes to the administration of Commonwealth Indigenous affairs policy.

Yarra Council opposes the abolition of the Aboriginal and Torres Strait Islander Commission (ATSIC). To this aim, Council has:

- Co-signed a letter (May 2004) to the Prime Minister, the Hon John Howard, in association with Darebin and Moreland Councils in opposition to the abolition of ATSIC, (see attached); and
- Passed a Council Resolution on 8 June 2004 in opposition to the Commonwealth Government's proposal to abolish ATSIC, and supporting the continuation of a national Indigenous body that is representative of Indigenous people and principles of self-determination and community control (see attached).

Yarra Council is strongly engaged with Aboriginal affairs, including the recent development of the Yarra Indigenous Partnerships Plan Wurundjeri Reconciliation and Social Justice 2004-2008. Throughout this process, ATSIC has played an important link between Council and local Aboriginal organizations, including liaison, advocacy, support and advice on a range of specific local Aboriginal issues.

Yarra City Council acknowledges the Wurundjeri people as traditional owners of the land within this municipality. A fair and just Reconciliation with traditional owners and true social justice for all Aboriginal people is fundamental to our nation's well being.

We encourage your Committee to consider the importance of Aboriginal selfdetermination and community control as integral to any changes to Indigenous affairs administration.
