

The Plebiscite Resolution?

Having seen the thirty questions being addressed by the Senate Inquiry to the Australian People, I would like to congratulate the Senate for its boldness in their introduction of the concept of direct government via questions 26, 27 and 28.

The mechanism of plebiscite, as against referendum, is novel for Australians. We are used to the limited scope of referenda. Plebiscites, on the other hand, open an enormous vista for populist action.

The timely introduction of plebiscite will raise public awareness of a unique opportunity for future active public participation in democratic government.

It could end the anomaly that, on a whole host of social issues (a small selection of which appears below) outcomes are determined by Federal and State Governments, which are at variance with public opinion (as determined by surveys).

The attached list is by way of example.

It is quite possible that, in the future, populist plebiscites could be introduced by Federal or State governments

Richmondism

Future Plebiscites Page 2

The Death Penalty

Whether the death penalty should be restored for gross crimes - such as serial murder, mass murder, gang rape and terrorism.

Gaol Obesity

Whether hard labour should be introduced into gaols for the health and occupation of inmates.

Citizenship

Whether free benefits should be given to non citizens.

Secession

whether social groups have the right to secede from the Commonwealth.

Public Funding for Political Parties

whether, in view of current public funding, political party leaders (president, secretary etc) should be elected by the public, if not, should public funding not be given to political parties.

Politicians' Salaries

Whether politicians salaries should be indexed to a basic wage.

Migration Restriction

Whether, in view of the collapse of essential services in Australian cities like Sydney (hospitals, water, railways, electricity and roads), current migration targets should reduced by 50-80%.

Expulsion of Terrorists

Whether all terrorists and other subversives should be expelled.
