- 1. Women Into Politics Inc is pleased to make a submission on the matter of an Australia Republic.
- 2. Women Into Politics supports the detailed submissions made to the Senate Committee of Enquiry into an Australian Republic by:
 - · Kim Rubenstein, Associate Professor of Law, University of Melbourne, and
 - Women for an Australian Republic
- 3. Women Into Politics' primary concern is that women must be full participants in all areas of Australian public life and to this end we were one of the women's organizations which developed and organized the Women's Constitutional Convention in Canberra prior to the Australian Constitutional Convention in 1998. Some three hundred women from all over Australia, representing women's organizations and individuals attended this event.

The consensus arising out of the Women's Constitutional Convention was:

• women supported an Australian Republic,

 there was no decision on whether the Head of State should be elected or appointed, but it was decided that the Australian people should be given the opportunity to decide this question through a plebiscite or referendum.

• women were concerned that the constitutional arrangements and procedures for the nomination or appointment of a Head of State must contain guarantees that provides for equality of women with men, and that women be given equal opportunity to become Head of State. This latter point is dealt with in detail in the submission made to your Committee from Kim Rubenstein, Associate Professor of Law, University of Melbourne. We commend her submission to you.

Women Into Politics believes that women, concerned for women's political equality remain of these views.
