AUSTRALIA'S INTERNATIONAL TAXATION AGREEMENTS RELATING TO INCOME TAX

As at 27 February 2004.

Australia's International Taxation Agreements are contained in, and governed by, the Commonwealth *INTERNATIONAL TAX AGREEMENTS ACT 1953* - referred to hereafter as the main Act.

The index to the Sections and Schedules of the main Act may be viewed on the Internet at http://scaleplus.law.gov.au/html/pasteact/1/678/top.htm which provides links to each piece of the Act.

Normally, the process by which the agreements come into force is:

- The content of the agreement is negotiated and agreed on a government-to-government basis by departmental officials.
- The agreement (treaty) is signed at Ministerial or Ambassador level and at this stage is still subject to ratification by the Parliaments of the two countries involved.
- In Australia, the proposed treaties are tabled in the Federal Parliament and are subject to examination by the Joint Standing Committee on Treaties which holds public hearings. Individuals and organisations are able to make submissions to the Committee at this stage. See http://www.aph.gov.au/house/committee/jsct/
- In due course the Joint Committee presents a report to the Parliament in regard to the proposed treaty.
- The Government introduces a Bill to amend the main Act by incorporating the provisions of the new treaty. The passing of the Bill ratifies the treaty from the Australian perspective.
- The treaty does not come into effect until it is ratified by the Parliaments of both countries.

When reading the main Act it should be noted that each treaty is covered by a section of the Act and that the text of the agreement/treaty is contained in a numbered schedule to the Act.

The table below lists alphabetically the countries with which Australia has double taxation agreements **relating to income tax** and indicates the relevant section and schedule for each country. The URL address in the right-most column is the link to the text of the agreement as contained in the relevant schedule.

NOTE

The URL addresses for the agreements are likely to change each time new amendments are incorporated into the on-line consolidation of the main Act.

We hope to recast the links whenever this occurs. However, should a link as shown below lead you to the text of an agreement with a country other than what you expected please take the following action:
