

I write to see if you would accept a man with the following history on your waiting list. The nature of his history is such that it can raise strong feelings from clinical staff and he has already been rejected as a referral to two aged care hostel facilities because of his history.

Mr J is diagnosed with schizophrenia. Mr J presents with a forensic psychiatric history following an index offence which occurred in 1993. He shot dead three men residing in home units where he lived at that time. The offence occurred in the context where Mr J was experiencing a delusion that two of the men were poisoning him with insecticide. The third man was shot following an altercation about keys with Mr J. He was charged with 3 counts of murder, 4 counts of maliciously shooting, 4 counts of maliciously discharging a firearm with intent to resist arrest. In 1994 he was determined to be not guilty-by reason of mental illness.

At the time of the offence, on psychlatric assessment, Mr J was assessed to be experiencing a paranoid psychosis and a paranoid personality disorder.

Mr J was transferred to Rozelle Psychiatric Hospital Rehabilitation services on 3rd March 05 from a rural psychiatric hospital. He now resides in semi-independent cottages where he has a room to himself and he cooks his own meals. He receives daily nursing review and supervision. He moved to Sydney to be closer to a small number of friends he has in the city. He is of a Croatian background and he has English competency.

Please note that Mr J is also an insulin dependent diabetic and his condition is well managed.
